### METHOD OF PAYMENT FORM

For Membership Dues and Religious School Fees:

- ACH payments are processed on the 5<sup>th</sup> and 20<sup>th</sup> of each month. (choose one by  checking box below)
- Payment of dues must be kept current to be considered a member in good standing.

**The balance of our dues will be paid as follows (please select only one of the options below):**

- Deduct one (1) payment of \$\_\_\_\_\_ on  5th or  20th of \_\_\_\_\_ (month).
- Deduct two (2) payments of \$\_\_\_\_\_ on  5th or  20th of \_\_\_\_\_ (month) & \_\_\_\_\_ (month).
- Deduct three (3) payments of \$\_\_\_\_\_ on  5th or  20th of the month of October 2016, January 2017 and April 2017.
- Deduct ten (10) monthly equal payments of \$\_\_\_\_\_ on the  5th or  20th of each month beginning August 2016 or immediately upon rejoining.

Other fees:

Members may request non-recurring fees and charges to be made via ACH. This must be done in writing (email is acceptable to [deskmaaven1@templebethdavid.org](mailto:deskmaaven1@templebethdavid.org) and will be billed on the 5th or 20th of the month in which the charge is incurred, whichever comes first).

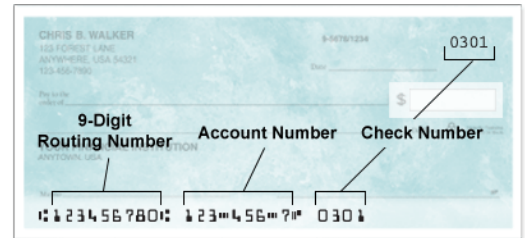
